The Organising Committee for the DCL Football 2019 will distribute information on the event in the coming weeks.

Please let us know of any women teams from your country that can play in the DCL competition. Each team must get their national federation agreement to play in the DCL. We can only accept a maximum of **3 women teams** from your country if you have national championships, **or 2 women teams** if you do not have national championships.

Priority will be given to the teams from countries that have a national championship, so the other teams will be possibly be reserve teams depending on the number of registered teams.

INFORMATION: The clubs have to pay the registration fee (100€ + deposit 100€) before 31<sup>th</sup> December 2018. If addition, the club must pay the registration fee for each player / team official (5€ per player), which must be paid upon arrival.

Dear friends.

The registration BY NAME with attached document, you can fill up to a minimum of **10 players** and a maximum of **15 players** with deadline by 17<sup>th</sup> March 2019.

Please special attention to **player number**. Number MUST relate to name of player. 15 players must wear set numbers between 1 and 99. The number 1 shirt shall be for the goalkeeper. Any questions on the numbering please let me know quickly.

You may replace any one player from the list of 15 players for **medical reason** with a maximum of **3 changes** to players and officials until 1 day before the competition (14<sup>th</sup> April 2019). You must show any medical evidence for the reason of replacement.

This club must get your national Federation agreement to play in the DCL with the ID number (Number of Licence included the approval of audiogram and insurance).

Please fill in this document and return to me by email in .doc format (Word format) with a copy to <a href="mailto:cguenedal.dcl@gmail.com">cguenedal.dcl@gmail.com</a> and <a href="mailto:tkraemer.dcl@gmail.com">tkraemer.dcl@gmail.com</a>.

Prior to the start of the DCL competition (14<sup>th</sup> April), in London (England), the club must pay the license for each player/official (individual 5€). The fees shall be paid before being allowed to participate. No other formats or currencies are accepted.

If the club does not send the list of players on time, a fine of 20€ will be imposed by DCL if is less than 4 week before the DCL Competition, 50€ if less than 3 week before the DCL Competition, 75€ if less than 2 week before the DCL Competition or 100€ if less than 1 week before the DCL Competition.

Important DCL Football Rules (http://www.deafchampionsleague.eu/rules/):

- 2.10 Prior to the start of the DCL competition, the license for each player (individual) to be paid to DCL shall be 5€ and for each official the fee shall be 5€. The fees shall be paid before being allowed to participate.
- 2.14 There is no age limited in the Men and Women DCL competitions. For any player under the age of 16, the club must provide parental authorisation. The player's parental authorisation must be sent by the Club to the DCL at least 4 weeks before the start of the DCL competition.
- 2.15 Each club must submit their list of players and a maximum of 4 club officials, but a minimum of 1 non-playing club official, to the DCL at least 4 weeks before the competition starts. The list of players and officials must provide the full name, date of birth and any medical conditions, which the DCL and OC need to be aware of (for example, diabetes, allergies, etc.). This is important in case of emergencies during the competition and possible communication difficulties. Once the club has registered their final list of players

(i.e. maximum of 15 players, 7 days before the competition), they can make a **maximum of 3 changes** to list of players and officials, on grounds of ill health/injuries, before the competition starts with the approval of their National Federation. Such changes must be supported with evidence (e.g. doctor note) and no fee or fine will be imposed.

If the club does not send the list of players on time before the DCL competition, the following fines are to be imposed by DCL:

a)	Less than 4 week before the DCL Competition	20€
<i>b)</i>	Less than 3 week before the DCL Competition	50€
c)	Less than 2 week before the DCL Competition	<i>75€</i>
d)	Less than I week before the DCL Competition	100€

DCL have discretion as to implementing/forfeiting the fine on receipt of a written request from the club with appropriate reason(s) given as to why the club has submitted their Players List late.

- 2.23 For the registration of players in the DCL Football Women competitions, each team must have a minimum of 10 players. The maximum number of players per team is 15. Each club can submit a maximum of 15 players on their Players List, but the Players List must be reduced to only 15 players at least 7 days before the competition starts. A fine of 50€ will be imposed by DCL on the offending club if they fail to confirm their final list of 15 players.
- 2.24 From the first match of the competition, all registered players must wear set numbers between 1 and 99. The number 1 shirt shall be for the goalkeeper. No number may be used by more than one player and no player may use more than one number in the course of the competition.

I would appreciate the registration by name (form) must be sent to DCL Football, before <u>17<sup>th</sup></u> March 2019.
